EXTRACT FROM THE REGULATIONS FOR THE MANAGEMENT OF THE BURIAL GROUND FOR THE BURIAL AREA OF THE CIVIL PARISH OF BRAMPTON

- Reg. 5. No gravestone, or erection of any kind shall be put up, nor shall any inscription or epitaph be placed thereon without the sanction of the Board, [i.e. Parish Council], being first obtained.
A specific design or drawing (in duplicate) showing the form, dimensions, and material of every tomb or monument, etc. proposed to be erected; and two copies of every inscription or epitaph proposed to be placed thereon must be left at the office of the Clerk of the Board for approval by the Board. And all gravestones, monuments, etc. must be of such stone or other material as shall be satisfactory to the Board. And no repairs or alterations will be permitted without the sanction of the Board.
- Reg. 6
No ordinary gravestones are to exceed *3 feet 6 inches in height, and **2 feet 6 inches in width.
The letters of the Sculptor's name to be placed on any gravestone, etc., shall not exceed half an inch in length.
- Reg. 8 The Board reserve to themselves the right of removing all gravestones or material which may be put up or placed in the Burial ground in contravention of any byelaw of the Board. AND ALSO at their discretion, and at the expense of the owner or owners, to repair or remove any such which may require to be repaired, and which may not have been repaired, after due notice from the Board to do so.
- Reg. 10 Persons erecting gravestones must use mats, canvas, or boards, or other means to protect the grass and walks as the Curator may deem necessary. And all rubbish must be removed forthwith. Materials must be conveyed into the Burial Ground by hand, or on carts or trucks with wheels not less than 4 inches in tyre [width].
- Reg. 11 All gardeners and workmen shall be subject to the control of the Clerk, and may be summarily removed by him from the ground upon any cause of offence. The Clerk shall also regulate the hours of their admission and departure.
- Reg. 12 No hewing or dressing of stones nor operations of any kind will be permitted within the Burial Ground, or in approaches thereto, unless specifically sanctioned by the Board or their officer.
- Reg. 16 All fees and charges must be paid at the time of notice and order are given and before the work is begun in respect of which they are payable.
